About Paint Protection Film

Our paint protection film (PPF) is engineered to safeguard your vehicle's paint from chips, scratches, and swirl marks. Most quality brands are 8 mils thick and applied directly to the exterior painted surfaces. V-Twin Skinz warrants Professional installation for 1 year. Individual manufacturer of Vinyl or PPF warrants against yellowing, staining, cracking, blistering, and delamination for set time on their documented warranty. This warranty excludes damage caused by accidents or impacts that penetrate the film.

Drying Time

PPF requires 3–4 weeks to fully cure, depending on weather conditions. Please refrain from washing your vehicle for at least 5 days post-installation. We recommend returning for inspection within 2–4 weeks.

Vehicle Condition

Vehicles must not have existing paint protection coatings (e.g., ceramic coatings), as these interfere with adhesion and may cause lifting or bubbling. PPF is designed for OEM factory paint only. Clients acknowledge and release V-Twin Skinz from any warranty or damage claims when PPF is applied to non-OEM surfaces.

Paint Disclaimer

Paint may lift on repainted or improperly prepped OEM panels. By authorizing V-Twin Skinz to proceed, clients accept this risk and waive any claims for damage incurred during installation.

Paint Chips

PPF helps prevent future paint chips but does not conceal existing ones. Installing PPF over chipped paint may result in visible imperfections. We advise against touch-up paint on small chips due to aesthetic concerns.

Installation Details

All PPF kits are precision-cut using software. Pre-cut kits may not cover edges around badges, washers, or trim. PPF is a protective layer—not invisible or matte—and cannot be applied to chrome or textured plastics. Custom-fit or bulk installs are available for an additional fee.

Restyling Paint Protection Film

Restyling PPF options include clear matte, patterned, and colored films. Badges and trim may need removal to wrap edges properly. Vinyl inlays and seams may be used to cover OEM paint. Additional charges apply for restyling installations.

Exposed Edges and Seams

While we aim to wrap all edges, some areas may remain exposed. Debris buildup is more noticeable on white or light-colored vehicles, especially with partial installs. Ceramic coating is recommended to reduce buildup. No warranty or reapplication is offered due to debris accumulation.

Headlight Coverage

PPF is not recommended for headlights due to HID features and factory coatings. Clients who opt for headlight film acknowledge the risks and release V-Twin Skinz from liability.

Film, Badge & Decal Removal

Removing film, badges, or decals may damage paint, glass, or defrosters. Clients authorize removal at their own risk and waive claims against V-Twin Skinz for any resulting damage.

Track or Off-Road Use

PPF warranties do not apply to vehicles used on racetracks or off-road. We strongly recommend ceramic coating the film and OEM paint to protect against tar and debris.

Imperfections

While we strive for flawless installations, minor imperfections such as dust contamination, orange peel texture, or visible pre-existing flaws may occur. Older or previously used vehicles may show more noticeable imperfections.

Door Handle Coverage

Due to curvature and frequent contact, some door handles cannot be effectively protected with PPF. If coverage is requested, no warranty applies. We recommend leaving handles unwrapped.
